

## **RESIDENTIAL RECYCLING PROGRAM**

### **BULK ITEM COLLECTION**

For disposal of Bulk items your pickup service is limited to one (1) item per week, for residents receiving regular trash/recyclable collection service.

Bulk item collection is provided during the same hours and days as your regular pick - up service. Large items to be collected include, but not limited to refrigerators, stoves, dishwashers, hot water heaters, washing machines, dryers, freezers, TV's, chairs, rolled carpet, desks, tables, mattresses, box springs, bed frames, sofas, lawn mowers (no oil / gas), toilets, sinks, window screens, doors, and similar household items. Any items containing FREON must be called in to Customer Service at Penn Waste Ph. 717-767-4456 to schedule pick up. all other items go to the curbside with regular trash.

### **LEAF WASTE**

In the fall the Township will pick up leaves and dispose of them. Leaves must be placed in piles along the edge of the road within the cartway or the berm. No branches or pet waste is to be put out with the leaves. Do not put leaves in any containers.

### EAST MANCHESTER TOWNSHIP RECYCLING PROGRAM

East Manchester Township's Ordinance 2003-1 states that all residential, commercial and industrial establishments are required to participate in the township's recycling program. **RECYCLING IS MANDATORY.**

All residential recycling and trash services are provided to the township by Penn Waste. All residents must participate in the program, if regular trash service is not used you must obtain the orange trash bags, (one for each quarter), at a cost of \$3.50. You must also recycle.

### RECYCLABLE ITEMS FOR RESIDENTIAL

To be in compliance with Recycling Ordinance 2003-1, you must recycle the following materials:

ALUMINUM FOOD AND BEVERAGE CONTAINERS  
BI-METAL, STEEL AND AEROSOL CANS

PLASTICS WITH SYMBOLS #1 through #7

CORRUGATED- CARDBOARD MUST BE FLAT

SHREDDED PAPER

PRINTER/COPIER PAPER, ENVELOPES

BOXBOARD ie: CEREAL, SODA, PIZZA, SHOE,

FOOD PACKAGING BOXES.

NEWSPRINT

HDPE PLASTIC CONTAINERS WITH THE SYMBOL  
#2 THRU #7 WHICH ARE MILK AND WATER BOTTLES,  
DETERGENT, SHAMPOO, BLEACH BOTTLES  
WITH CAPS REMOVED.
