

EAST MANCHESTER TOWNSHIP
TEMPORARY PERMIT - Yard Sale, Garage Sale, Craft Show, or the like.

The undersigned applies for a permit to hold a yard sale or similar type of sale, as follows, with the understanding that East Manchester Township allows by Chapter 249 of the Code of the Township of East Manchester (adopted by ordinance 2000-5), two (2) sales per calendar year for no more than three (3) consecutive days each time per property and no sale shall create a public safety or traffic hazard on public streets or roads within the Township.

In the event that the yard sale creates a public safety or traffic hazard the Permit Officer or an officer of a duly authorized Police Department having jurisdiction within the Township shall be authorized to revoke any permit on the spot, as well as an order to cease and disburse.

Per section 249-4 (A) Failure to obtain a permit for a yard sale, or failure to abide by any of the provisions of this chapter shall constitute a violation of this chapter. (B) This chapter shall be enforceable by any permit officer of the Township or by the duly authorized Police Dept. with jurisdiction within the Township. (C) A violation of this chapter may be enforced by the issuance of a nontraffic summary citation by the permit officer or the Police Dept., and, upon conviction in a summary proceeding before a Magisterial District Judge of competent jurisdiction, the violator maybe fined an amount not to exceed \$1,000.00, together with all court costs as permitted by law. In default of payment thereof, the defendant may be sentenced to imprisonment for a term not exceeding 90 days. Each day or portion thereof that such violation continues or is permitted to continue shall constitute a separate offense, which shall be subject to prosecution as such.

Zoning Chapter 255 - **ONE (1) temporary (T-5) directional sign (maximum of 2 sq. ft.) may be placed AT THE END OF THE STREET WITH PROPERTY OWNER'S PERMISSION, not to exceed one week of placement and NOT on utility or traffic poles. You are responsible for removal of the sign immediately afterward.**
